Agreement terms are measured from in-service date and zero miles. Chevrolet Protection Plan additive terms are available for up to 8 years or 150,000 miles. Agreement terms are measured from the Agreement purchase date and odometer reading at the time of purchase. 2 Platinum exclusionary coverage includes all mechanical parts of the vehicle in the event of a mechanical breakdown unless they are specifically listed as not covered in the Agreement. 3 Any necessary replacement parts will be replaced at the program administrator's discretion using new, remanufactured, or like-kind and quality parts. 4 Towing reimbursement is eligible up to \$100 per incident if required due to a covered mechanical breakdown. 5 Additional exclusions may apply. Please see the Agreement for specific coverage details, including limitations and exclusions.
